Private NHCDC Collection Round 16 – Extension of deadline

The NHCDC Team has advised that to date they have received the submissions for approximately 65% of separations from private hospitals to enable them to publish a Round 16 costing study, however the deadline for data submission has been extended until COB of Friday 8 February 2013. APHA Indicator Collection – Transition Deadlines

All participants are reminded that the deadline for submission of data for the fourth quarter of 2012 is 15 February 2013. Although it will be possible to submit data after this date, participants are requested to make every effort to meet the deadline so that all participants will be able to access reliable benchmarking data ahead of 31 March. Participants will cease to have access to the Collection after 31 March. NSW - New Infectious Disease Notification Requirements

The NSW Public Health Act 2010 and the Public Health Regulation 2012 commenced on 1 September 2012. A new provision allows for medical practitioners and pathology laboratories to make a notification if they believe a patient is suffering from a medical condition or disease that may pose a significant risk to public health even if it is not included in the notifiable conditions schedule.
