Ministerial Discussions

Last Monday, APHA CEO, Michael Roff met with the Victorian Minister for Health and Minister for Ageing, the Hon David Davis MLC.

Discussions covered a wide range of issues including private patients in public hospitals, elective surgery tendering, the role of private hospitals in Victoria's health service delivery planning, the federal government's proposals to change the indexation of health insurance rebates and health workforce training in the private sector.

Health Workforce Roundtable

Last Thursday, APHA joined with Catholic Health Australia and other private sector representatives for a Private Healthcare Roundtable as part of the Australian Government Review of Health Workforce Programs.

The objective of the review is to analyse and assess the appropriateness, effectiveness and efficiency of Commonwealth programs and activities designed to increase, train, support, plan for and distribute the Australian health workforce.

There was a high degree of consensus amongst participants about the as yet untapped potential of the private sector to expand health workforce training capacity. A range of barriers to this expansion were identified and number of possible solutions discussed, including:

• A better understanding of the priorities of the private sector

- Better integration of the private sector into planning processes
- A level playing field for allocation of funding
- The removal of the need for state-based approval processes
- More responsiveness from Universities about the quality of graduates they produce
- The need for a Private Sector Advisory Board to report to the Minister and/or a Private Training Entity to coordinate funding for health workforce training in the private sector.

The Review is expected to produce a draft report by the end of 2012 and a final report by the end of March 2013.

Circular 2012-67: PRIVATE HEALTH INSURANCE (BENEFIT UIREMENTS) AMENDMENT RULES 2012 (NO. 7)

The Private Health Insurance (Benefit Requirements) Amendment Rules 2012 (No.7) (the Amendment Rules) were registered on the Federal Register of Legislative Instruments (FRLI) on 31 October 2012 (F2012L02114) and take effect on 1 November 2012, or the day after registration.

On 1 November 2012, changes to the Medicare Benefits Schedule (MBS) items took effect. The Amendment Rules amend MBS items in Schedules 1 and 3 of the Private Health Insurance (Benefit Requirements) Rules 2011 (the Principal Rules). The changes are necessary to maintain consistency between the MBS item codes listed in the Principal Rules and the MBS from 1 November 2012.

The amendments also reflect an indexation of 1.9% to the MBS Schedule fees in Schedule 1 of the Principal Rules.

Federal Minister Welcomes Leadership on Medical Interns

Health Minister Tanya Plibersek on Friday congratulated those jurisdictions that are working with the Commonwealth to fund additional medical internship training in public and private hospitals.

Under the agreement WA, the ACT, Queensland and NT will fund an additional 32 internships in their public hospitals. In return the Commonwealth will fund an additional 84 intern places in 2013, almost all in private hospitals.
