s 2013 draws to a close, I would like to take this opportunity to wish you all a very happy, healthy and safe Christmas and New Year season - I look forward to bringing you more Quality in Focus news throughout 2014. I would also like to take his opportunity to acknowledge the tireless efforts and dedication of Michael Roff and the team at APHA. The work of APHA in ensuring communication flows and supporting efforts and endeavours dedicated to the area of safety and quality is nothing short of outstanding.

We are now almost at the end of the first year of implementation of the new Australian Health Services Safety and Quality Accreditation Scheme. It appears that the private hospital sector has risen to the challenge and reaped the rewards of all of the planning and preparation undertaken in the lead up to 1 January 2013.

An Update on Accreditation to the **NSQHSS**

There are 1,320 public and private hospitals and day hospitals in Australia, which are eligible to be assessed as part of the Australian Health Services Safety and Quality Accreditation Scheme. Approximately 420 facilities will be assessed by the end of 2013.

As at 30 September, 297 facilities have had an accreditation assessment, 77% private and 23% public. Approximately 64% have undergone a midcycle assessment to Standards 1,2 and 3, while the remaining 36% have being Organisational Wide surveys to the 10 NSQHSS. Of these:

- 51% have had accreditation status confirmed
- 49% have had actions that need to be addressed within 120 days

The Australian Commission on Safety and Quality in Health Care (ACSQHC) has collected information from accrediting agencies on health services awarded 'met with merit' when assessed to the NSQHSS.An analysis of this information shows that approximately half of the health services are awarded at least one 'met with merit' rating and this is consistent across jurisdictions, health service size and type. The actions that are awarded 'met with merit' most frequently are:
